ORDINANCE NO. 10-14-97A

AN ORDINANCE ESTABLISHING THE PLACEMENT OF STOP SIGNS WITHIN THE CITY OF COOLIDGE AND PROVIDING FOR PENALTIES AND PUBLICATION AND SAVINGS CLAUSE.

WHEREAS, THERE EXISTS A NEED TO ESTABLISH THE PLACEMENT OF STOP SIGNS IN THE CITY LIMITS FOR THE PROTECTION AND SAFETY OF THE HEALTH AND WELFARE OF THE CITIZENS OF COOLIDGE;

NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COOLIDGE. TEXAS:

IT SHALL THEREFORE BE UNLAWFUL FOR MOTORIST TO DISOBEY THE PLACEMENT OF ANY AND ALL STOP SIGNS WITHIN THE CITY LIMITS OF COOLIDGE, TEXAS.

ANY PERSON UPON CONVICTION OF VIOLATING SAID ORDINANCE SHALL BE FINED A PENALTY IN ANY SUM NOT EXCEEDING TWO HUNDRED DOLLARS (\$200.00).

THE PLACEMENT OF ANY AND ALL STOP SIGNS SHALL BE UNDER THE AUTHORITY OF THE CITY COUNCIL OF THE CITY OF COOLIDGE AT THEIR DISCRETION.

THIS ORDINANCE SHALL BE EFFECTIVE FROM AND AFTER ITS PASSAGE AND PUBLICATION AS PROVIDED BY LAW, AND IT IS ACCORDINGLY SO ORDAINED.
